MEMORANDUM OF UNDERSTANDING

This memorandum of understanding hereinafter referred as MoU is made on 19th Day of June 2024

BETWEEN

Gour Mahavidyalaya, having its registered office at Mangalbari, Malda, West Bengal - 732142 hereinafter referred to as 'College'

AND

Oreka Diagnostics, having its registered office at NH-34, No.3 Govt. Colony, Malda, West Bengal

1. Objective

The objective of this MOU is to express the willingness of both the institutions to engage in an effort to promote [academic/ cultural/ research] atmosphere and [social/ cultural/ outreach] activities. Various departments of Gour Mahavidyalaya, Malda and Oreka Diagnostics, Malda, will enhance the quality in the field of teaching and research by sharing and exchanging faculties, experts and students.

Specific academic activities under this MoU will be identified through consultation between the faculty of the Gour Mahavidyalaya and the administrator of the organization.

Each [college/ organization] agree to provide their academic and technical assistance to carry out specific activities which will include hosting conference/workshops/symposium/ awareness programme, implementing skill-based training programs, undertaking extension activities, starting new add-on courses and developing research atmosphere.


2. General Terms of MOU

- A. Duration of MOU:** This MOU will be effective from the date of agreement and will have an initial duration of five years. There is also a provision to extend the MOU.
- B. Coordination:** In order to carry out and fulfill the aims of this agreement, each college/organization will empower an appropriate faculty to coordinate the implementation of activities. The concerned faculties will meet regularly to discuss about plan, implementation and progression of the activities.
- C. Technical and Financial Support:** Technical & financial support of each activity will be equally shared by the colleges / organization concerned.
- D. Confidentiality:** At any time, after executing the activities of this MOU each college/organization agrees that none of the college(s) / organization will disclose any information in relation to these activities without consent of both sides.
- E. Termination of MOU:** The partnership covered by this MOU shall be terminated upon the completion of the agreed period of five years. The agreement may also be terminated with a written three months notice from both sides.
- F. Extension of Agreement:** The MOU may be extended according to the willingness of the both colleges/organisation with prior intimation and permission of the authorities, two months before the end of the MOU.
- G. Communications:** All notices, documents and any other communications under this agreement in connection herewith will be in written form and sent to the postal address or email, or fax of the colleges concerned. Any notice shall be effective from the date on which it is signed.
- H. Addendum:** Any Addendum to this MOU will be in written form and signed by authorities of Gour Mahavidyalaya, Malda & Oreka Diagnostics, Malda.
- I. Programme Consult:** All programmes will be taken up by the concerned department of the college with prior consultation with the corresponding [department/ organization of the other college].
- J. Venue of the Programme:** Each college / organization will organize any programme on their own premises in collaboration with other college by using their own assistance and resources. A third place may be treated as a venue of any programme but that must be done after a discussion and consultation of the two college(s) / organization with the financial sharing.

Some probable activities both the organizations can materialize

- A. Internship Programs:** Students from college, especially those studying medical or health related fields, could intern at the Oreka diagnostic center.
- B. Joint Research Projects:** Both institutions could collaborate on research projects of mutual interest.
- C. Diagnostic Training and Workshops:** Oreka diagnostic center can organize workshops and training sessions for students providing insights into the latest diagnostic technologies and their applications in healthcare.
- D. Career Guidance and Placement:** Oreka diagnostic center can provide career guidance and placement services to students of the Gour Mahavidyalaya, helping them find employment opportunities in the field of diagnostics.
- E. Health Camps and Awareness Programs:** Both the parties can jointly organize health camps and awareness programs.
- F.** Both parties assume that this agreement does not go against the rules and regulations of the Government of WB & UGC.


The terms and provisions in this MoU also apply to any subsequent addendum to this agreement.
