

This document constitutes an agreement between Department of Political Science, Gour Mahavidyalaya and Learnet Institute Skills, Malda at the Principal's chamber of Gour Mahavidyalaya at Mangalbari, Malda, Pin- 732142.

**1. Objective**

The objective of this MOU is to express the willingness of both the institutions to engage in an effort to promote skills and employability in various spheres and activities. Specific training programme under this MOU will be organized through consultation between college authority and Learnet Institute of Skills, Malda. Each institution/ organization agrees to provide their academic, technical and infrastructural assistance to carry out specific activities which will include training programme for skill enhancement and to provide employment opportunities.

**2. General Terms of MOU**

- A. Duration of MOU:** This MOU will be effective from the date of agreement and will have an initial duration of five years. There is also a provision to extend the MOU.
- B. Coordination:** In order to carry out and fulfill the aims of this agreement, each institution will coordinate in proper manner for the implementation of activities. The concerned faculties will meet regularly to discuss about plan, implementation and progression of the activities.
- C. Technical and Financial Support:** Technical & financial support for each activity will be equally shared by both the institutions.

- D. Confidentiality:** At any time, after executing the activities of this MOU each college agrees that none of the colleges will disclose any information in relation to these activities without consent of both colleges.
- E. Termination of MOU:** The partnership covered by this MOU shall be terminated upon the completion of the agreed period of four years. The agreement may also be terminated with a written three months' notice from both sides.
- F. Extension of Agreement:** The MOU may be extended according to the willingness of the both institution/organizations with prior intimation and permission of the authorities, two months before the end of the MOU.
- G. Communications:** All notices, documents and any other communications under this agreement in connection herewith will be in written form and sent to the postal address or email, or fax of the colleges concerned. Any notice shall be effective from the date on which it is signed.
- H. Addendum:** Any Addendum to this MOU will be in written form and signed by authorities of both the institution/organizations.
- I. Programme Consult:** All programmes will be taken up by the concerned department of the college with prior consultation with the corresponding institutions
- J. Venue of the Programme:** Each institution/organizations will organise any programme at Gour Mahavidyalaya by using their own assistance and resources. Any other place may be treated as a venue of any programme but that must be done after a discussion and consultation of the two institution/organizations with the financial sharing.

The terms and provisions in this MOU also apply to any subsequent addendum to this agreement.

The parties have executed this MOU on 07/02/2023 and will remain valid up to 4 years from the date of signing.
