This Memorandum of Understanding (MoU) is made and entered into as of 05, April, 2023

By and between:

Gour Mahavidyalaya, a leading educational institution in Malda, West Bengal is hereafter referred to as "College".

And

Rajadighi Community Health Service Society (RCHSS), a leading non-Governmental Organisation of Malda, hereafter referred to as "NGO" and

WHEREAS, both parties share a commitment to fostering community engagement and social development in Malda, West Bengal.

NOW, therefore, in consideration of the foregoing premises and the mutual covenants contained herein, the parties agree as follows:

Scope of Collaboration

The parties will collaborate on the following initiatives:

Social Service:

College has adopted a village and all social work and development works in this adopted village will be conducted in consultation and collaboration with the NGO.

Awareness Programs:

Regular meetings will be held with the NGO to discuss matters related to other social works such as observing particular days, holding awareness programs and organizing special camps (up to Seven-Days) on health issues in the adopted village and beyond.

Joint Events and Activities:

The parties will organize joint events for the local community, such as public forums on local issues, educational ventures to improve the numeric and alphabetical literacy in village schools, in undertaking plantation drive.

Fund Sharing:

The college will provide necessary funding for undertaking specific works. The NGO will only carry out feedback survey, maintain contact with villagers and look after the infrastructure and development works from time to time. Depending on availability of funds, the NGO shall collaborate with us in holding programs as well.

Social Assistance:

The NGO will assist the college in preparing and implementing plans in the adopted village.

College will:

Nominate qualified students/NSS Volunteers for internship/training opportunities in the NGO to develop skills for social work.

Nominate faculty members/NSS Program Officers to maintain communication and regular contact with the NGO

1. Intellectual Property

Each party shall retain ownership of all intellectual property rights associated with its respective contributions to the collaboration. Any joint intellectual property created during the collaboration will be jointly owned by both parties and subject to a separate agreement.

2. Term and Termination

This MoU shall remain in effect for five years, commencing on the date hereof and may be renewed by mutual consent of the parties. This MoU may be terminated by either party on one month notice prior to termination.

3. Confidentiality

Each party agrees to keep confidential all information received from the other party in connection with this MoU, except for information that is already publicly known or that is independently developed by the receiving party.


4. Entire Agreement

This MoU constitutes the entire agreement between the parties concerning the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.

5. Amendment

This MoU may be amended only by a written agreement signed by both parties.


