Objectve(s):

This memorandum establishes a collaborative partnership between the First Party and the Second Party. It aims to facilitate joint programs related to providing ambulance service to the local people, First Aid Training, Blood Donors' Motivation, Plantation, Home nursing Training and Health awareness programme etc. Additionally, the agreement seeks to promote collaborative activities as agreed upon pertaining to discussion and consensus from both the parties.

General Terms and Conditions:

- 1. The agreement is effective from 7th January, 2023, for a period of five years.
- 2. Any modifications to the agreement require mutual approval and signing by both Parties.
- 3. Each Party may appoint a nodal officer to oversee collaborative activities.
- 4. Faculty Members from both Parties can participate in the activities.
- Collaborative activities will occur on the premises of each Party or at an agreed-upon thirdparty location.
- Financial, technical, and academic support decisions must be mutually agreed upon. Both Parties can provide support for various initiatives.
- 7. There shall not remain any compulsion on any of the Parties to carry out programs.
- 8. The agreement will terminate after five years or upon written notice from both Parties.
- 9. Extension or renewal of the agreement is possible with mutual consent.
