## NOTIFICATION RELATED TO INCOMPLETE SUBMISSION AND VERIFICATION OF DEB ID FOR PG, BLIS AND ADVANCE DIPLOMA ADMISSION (2024-25)

As notified against admission notification vide memo No.: Reg/1301 and Reg/1302 dated 23.12.2024 it was mandatory for the applicants to submit and verify DEB ID for getting admission to PG, BLIS and Advance Diploma programme for session January 2025.

University has issued provisional enrolment certificate for those applicants who have successfully submitted and verified DEB ID during admission period. Those applicants should visit respective admission portal (PG courses: <a href="mailto:pg.wbnsouadmissions.com">pg.wbnsouadmissions.com</a>; BLIS and Advance Diploma: blis.wbnsouadmissions.com) to download provisional enrolment certificate.

As intimated earlier, University has decided to cancel those application against which applicants have not completed the DEB ID submission and verification during admission period from 30.12.2024 to 28.03.2025.

However, the respective applicants can either get the fees (as paid during admission) refunded or may get accommodated in the upcoming admission session of respective programmes. Therefore, applicants who have not completed DEB ID submission and verification are requested to submit their choice through the following google form (Click here to access google form) with in 28.05.2025.

Candidates, who have not completed DEB ID submission and verification should note following points:

- 1. Only **one response will be accepted against each application id** through the google form. In case of multiple response received against same application id, last response will be accepted and all earlier response(s) will be discarded by the University.
- 2. If candidate(s) **fails to submit their choice of option** through the google form with the stipulated time, **University will refund the fees** (as paid during admission).
- 3. Fees will be refunded by crediting the amount to the account through which respective candidate(s) has (have) paid the admission fees. University will not refund the amount by any other means.
- 4. Refund process will be initiated after 28.05.2025 and will be completed 28.06.2025 (tentatively).
